- Anritsu Capital-cost Evaluation: Net operating profit after tax - Invested capital cost
- Net debt-to-equity ratio: (Interest-bearing debt - cash and cash equivalents) / (Net assets - Stock acquisition right)
- Interest coverage ratio: (Operating income + Interest and dividends income) / Interest expenses
- Dividend payout ratio: Total cash dividends / Net income
- Dividends on equity: Total cash dividends / Net assets
